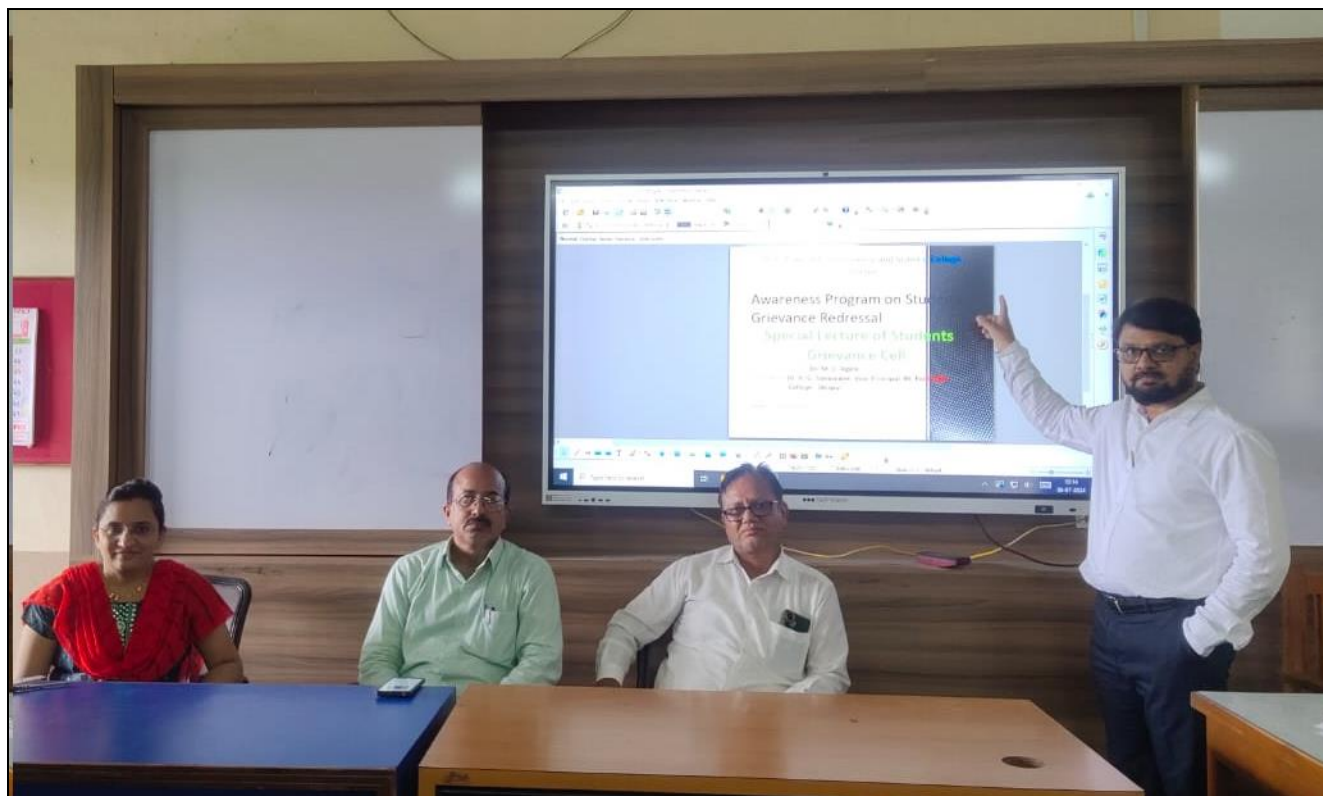

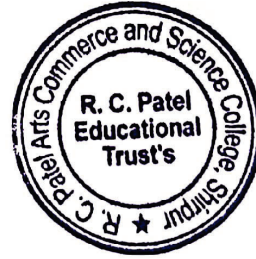
## Student Grievance Redressal Committee Action Report
