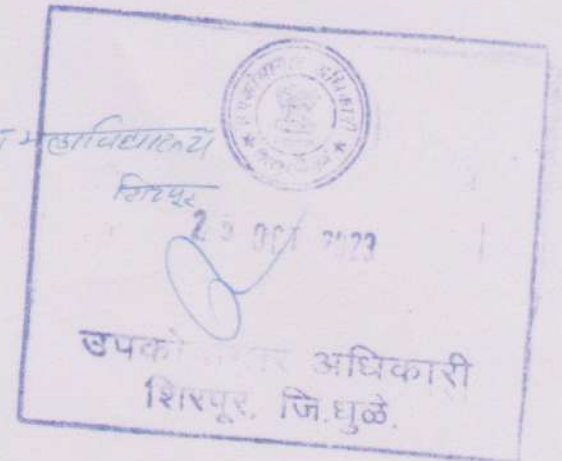

MEMORANDUM OF UNDERSTANDING (MoU)

BETWEEN

RCPET's, R. C. Patel Arts, Commerce and Science College, Shirpur

AND

SVKM'S Ketakiben Mukeshbhai Patel Central Library, Shirpur

This Memorandum of Understanding (hereinafter called as the 'MoU') is entered in to on Saturday of 09/12/2023 by and between

RCPET's, R. C. Patel Arts, Commerce and Science College, Shirpur, the First Party represented herein by its Principal, Dr. D. R. Patil, R. C. Patel Arts, Commerce and Science College, Shirpur.

WHEREAS:

A) First Party is a Higher Educational Institution named: **RCPET's, R. C. Patel Arts, Commerce and Science College, Shirpur**

B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.

C) The Parties intent to cooperate and focus their efforts on cooperation within area of Personality Development Program, Startup Incubation and Support, Legal, Financial, and Resource Support, Dynamic Website Development, Guest Lectures and, Access to Online Courses, etc.

D) **SVKM'S Ketakiben Mukeshbhai Patel Central Library, Shirpur** - the Second Party is engaged in Public Library

NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1

CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish co-operation.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities.
- 1.3 The parties shall co-operate with each other and shall as promptly as is responsibly practical, relevant agreement.

CLAUSE 2

SCOPE OF THE MoU

- 2.1 A Memorandum of Understanding among a shared print program's partner libraries is integral to establishing and reinforcing member libraries' commitment to the program and each other. It allows for the development of trust and shared understanding of policies and practices.
- 2.2 Interlibrary loan (abbreviated ILL, and sometimes called document delivery, document supply, interlending, interlibrary services, interloan, or resource sharing) is a service that enables patrons of one library to borrow physical materials and receive electronic documents that are held by another library.
- 2.3 Guest Lectures and Library members Interaction: Second party will provide experienced professionals to share insights and connect with students.
- 2.4 Access to Online Study materials: Second party will provide online educational resources for skill enhancement and compitativte examination.
- 2.5 Freelancing Services: Second party will offer opportunities for students to freelance and gain practical experience.
- 2.6 Virtual Incubation Support: Second party will provide support startups remotely with resources and guidance.
- 2.7 Governmental Services: Second party will provide assistance with government-related employments information.

2.8 Expertise of library and information science: First party will provide the expertise of library and information science for day to day activities of the second party.

2.9 Participants: First party will provide the student participants for the functioning of second party.

2.10 Online Tech Support: Second party will offer technical assistance and solutions online.

2.11 There is no financial commitment on the part of the **RCPET's, R. C. Patel Arts, Commerce and Science College, Shirpur**, the first party to take up any program mention in MoU. If there is any financial consideration, it will be dealt separately.

2.12 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required.

CLAUSE 3

VALIDITY

3.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period, the Second Part.

CLAUSE 4

RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership.
