In accordance with the desire to promote cooperation in Education, Training, Research & Development , sharing of knowledge and participation in competitions on a mutual basis, the **Audyogik Tantra Shikshan Sanstha's Institute of Industrial and Computer Management and Research (ATSS's IICMR-MCA)** and **R.C PATEL ARTS ,COMMERCE AND SCIENCE COLLEGE, SHIRPUR** hereby enter into an agreement to establish a program for cooperation in areas of mutual interest, and in accordance with the terms and conditions set out in this Memorandum of Cooperation (the Agreement).

**Audyogik Tantra Shikshan Sanstha's Institute of Industrial and Computer Management and Research** herein after referred to as "IICMR" having Its registered office at Pradhikaran Campus HS-2, Sector 27A, Behind Tukaram Garden, Pradhikaran, Pune 411044, Maharashtra, India.

IICMR is a reputed IT, and Business Management Institute in Pune established in 2002 affiliated to Savitri Bai Phule Pune University. The institute offers MBA and MCA programs approved by AICTE , New Delhi and Post Graduate Research Center affiliated to Savitri Bai Phule Pune University. (<https://www.iicmr.org>)

R.C Patel Arts,Commerce and Science College, Shirpur affiliated to KBC North Maharashtra University here after referred as RCPACS. Currently, the college offers Under graduate and Post graduate level programs in Computer Science.

**A. Objectives**

The purpose of this Agreement is to establish a partnership to further the mutual interests and to foster and develop cooperation between the two organizations in accordance with their individual mission and objectives, especially in respect of conduct of training programs, competitions, sharing e-resources to promote research culture.

IICMR and RCPACS agree:

1. Participation in Competitions and Conferences.
2. Judging various competitions.
3. Conducting expert sessions on recent trends in the field on Information Technology.
4. Promoting research culture by sharing e-Library resources-EBSCO. The credentials will be shared upon request on official mail.

#### **B. Co-ordination**

Each institution shall appoint one member of its teaching/research functions to coordinate the program on its behalf. They will provide such academic and administrative support as may be required for the purpose of settling any issues arising during the effective term of this agreement and shall supervise the activities conducted under this Agreement. The coordinators along with other nominated persons will periodically review and identify ways to strengthen cooperation between the two institutions.

#### **C. Duration of the Agreement**

This Agreement will take effect from the date it is signed by representatives of the two institutions. It will remain valid for five years and may be continued thereafter after suitable review and mutual agreement.

Either party may terminate the Agreement by giving written notice of not less than 30 (thirty) days' notice to expire on the proposed termination date. The revocation of the MoU shall only be prospective and will not affect the rights/obligations arising out of acts done/occurred prior to the termination of the MOU.

#### **D. No Legal Obligations**

The parties agree that the provisions contained in this MoU do not create any legal obligations between the Parties.

#### **E. Confidentiality**



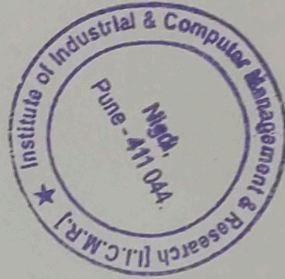
